For research purposes, smaller and more rural cities located within a reasonable distance to larger cities are combined into single geographical regions called "metro areas" to help collect as much feedback and data as possible. Bogotá has the largest number of listed lawyers.

Lawyers who are nominated for consideration are voted on by currently recognized Best Lawyers working in the same practice area and located in the same geographic region. Our awards and recognitions are based purely on the feedback we receive from these top lawyers. Those who receive high peer reviews undergo a thorough verification process to make sure they are currently still in private practice. Only then does Best Lawyers recognize these lawyers.
