## **307 Lawyers Recognized in 9<sup>th</sup> Edition of *The Best Lawyers in Puerto Rico*<sup>®</sup>**

In addition to historic individual lawyer recognitions and “Lawyer of the Year” awards, seven firms received a “Law Firm of the Year” award in ten practice areas. “Law Firm of the Year” awards recognize a single top firm for its work in a specific legal practice area nationwide. Awards are determined based on a handful of factors including lawyer feedback, the number of lawyers included in Best Lawyers for that firm and practice area, the number of office locations a firm has, historical analysis of the firm’s “Lawyer of the Year” awards, materials submitted by firms and the firm’s overall scope and areas of expertise.

For research purposes, smaller and more rural cities located within a reasonable distance to larger cities are combined into single geographical regions called “metro areas” to help collect as much feedback and data as possible. Puerto Rico, as defined by Best Lawyers, is composed of two metro areas with San Juan having the largest number of listed lawyers.
