Best Lawyers® Announces 2023 *The Best Lawyers in Chile*™

The 2023 edition of *The Best Lawyers in Chile*™ recognizes the professional excellence of 1,058 lawyers in 53 practice areas. 38 of these lawyers earned the "Lawyer of the Year" distinguishment, awarded to the lawyer with the highest peer-review feedback in their practice area and metropolitan area.

In addition to the individual lawyer accolades, 18 law firms were bestowed "Law Firm of the Year" awards in the 13th edition. "Law Firm of the Year" awards recognize a single top firm for its work in a specific legal practice area nationwide. Awards are determined based on a handful of factors including lawyer feedback, the number of lawyers included in Best Lawyers for that firm and practice area, the number of office locations a firm has, historical analysis of the firm's "Lawyer of the Year" awards, materials submitted by firms and the firm's overall scope and areas of expertise.

For research purposes, smaller and more rural cities located within a reasonable distance to larger cities are combined into single geographical regions called "metro areas" to help collect as much feedback and data as possible. Santiago has the largest number of listed lawyers.

Lawyers who are nominated for consideration are voted on by currently recognized Best Lawyers working in the same practice area and located in the same geographic region. Our awards and recognitions are based purely on the feedback we receive from these top lawyers. Those who receive high peer reviews undergo a thorough verification process to make sure they are currently still in private practice. Only then does Best Lawyers recognize these lawyers.
