For research purposes, smaller and more rural cities located within a reasonable distance to larger cities are combined into single geographical regions called "metro areas" to help collect as much feedback and data as possible. "Lawyer of the Year" awards are designated through these metro area distinctions. New England, as defined by Best Lawyers, is composed of six states: Connecticut, Maine, Massachusetts, New Hampshire, Rhode Island, and Vermont.

"Lawyer of the Year" honorees are based on extremely high overall feedback within specific practice areas and metropolitan regions. *New England's Best Lawyers* "Lawyer of the Year" section includes a feature on Laurie R. Bishop, lawyer at Hirsch Roberts Weinstein LLP, who was named the 2020 Education Law "Lawyer of the Year" in Boston.
