"Lawyer of the Year" awards are designated through these metro area distinctions. *South Florida's Best Lawyers* publication contains four metro areas: Fort Lauderdale, Fort Myers, Miami, and West Palm Beach.

"Lawyer of the Year" honorees are based on extremely high overall feedback within specific practice areas and metropolitan regions. *South Florida's Best Lawyers 2020* "Lawyer of the Year" section includes a feature on Tama Beth Kudman who was named the 2020 Criminal Defense - White Collar "Lawyer of the Year" in West Palm Beach.
