"Lawyer of the Year" honorees are based on extremely high overall feedback within specific practice areas and metropolitan regions. *Georgia's Best Lawyers* "Lawyer of the Year" section includes a feature on Kevin Miner, partner at Fragomen, Del Rey, Bernsen & Loewy, who was named the 2021 "Lawyer of the Year" in Atlanta for Immigration Law.
