Northern California, as defined by Best Lawyers, is composed of six metro areas: Fresno, Oakland, Sacramento, San Francisco, San Jose, and Santa Rosa.

"Lawyer of the Year" honorees are based on extremely high overall feedback within specific practice areas and metropolitan regions. *Northern California's Best Lawyers* "Lawyer of the Year" section includes a feature on R. Lewis Van Blois, partner at Van Blois Law, who was named the 2021 Product Liability Litigation – Plaintiffs "Lawyer of the Year" in Oakland.
