"Lawyer of the Year" awards are designated through these metro area distinctions. South Florida, as defined by Best Lawyers, is composed of four metro areas: Fort Lauderdale, Fort Myers, Miami, and West Palm Beach.

"Lawyer of the Year" honorees are based on extremely high overall feedback within specific practice areas and metropolitan regions. *South Florida's Best Lawyers* "Lawyer of the Year" section includes a feature on Andrew B. Yaffa, partner at Grossman Roth Yaffa Cohen, who was named the 2021 Medical Malpractice Law - Plaintiffs "Lawyer of the Year" in Miami. Yaffa was previously recognized as the Medical Malpractice Law - Plaintiffs "Lawyer of the Year" in Miami in 2016 and 2019.
